CLASS RULES & REGULATIONS

- 1. ENROLLMENT:** Pre registration is required for all training. Students must provide two forms of valid identification at all times. A registration form shall be received at least seventy-two (72) hours prior to training. If accepted by New Age Protection Training Academy, a signed copy of this agreement will be returned to the student. Once registered for class, a registrant becomes a student of the Academy, not an employee of New Age Protection, Inc.
- 2. TUITION & FEES:** Tuition is payable in full according to the payment method selected by the student on the registration form. Tuition is payable in U.S. funds, by certified check on a U.S. bank, credit card, bank card, or money order. Tuition for the courses is included on the registration form. Tuition or fees not listed can be obtained by calling New Age Protection Training Academy at 703-912-3057.
- 3. CERTIFICATES & QUALIFICATIONS:** A certificate is awarded upon course completion when the student satisfactorily completes the course and passes an examination. Those who fail to qualify on a shooting range course or any examination will receive one opportunity to re-qualify.
- 4. ENTRANCE:** Student admission is at the discretion of the New Age Protection Training Academy Director. Students must be at least 18 years of age, possess either a high school diploma or a G.E.D. equivalency, and complete the New Age Protection Training Academy admissions application process.
- 5. INSTRUCTION:** Students are responsible for acquiring the appropriate course supplies necessary to successfully complete the course.
- 6. FOREIGN STUDENTS:** All instruction is conducted in English.
- 7. ATTENDANCE:** Students who miss training may reschedule within thirty (30) days. A rescheduling fee of \$25 will be charged to the registrant. All fees are nonrefundable.
- 8. ATTIRE:** Appropriate civilian clothing is required this includes: blue jeans, slacks, t-shirts, sweaters, hats, coats, jackets and athletic shoes. Inappropriate civilian clothing includes: cutoffs, shorts, halter tops, tank tops or any other clothing item the training supervisor deems inappropriate.
- 9. JOB REFERRALS:** New Age Protection Training Academy will assist each graduate with placement skills development. However, New Age Protection Training Academy does not guarantee job placement or employment.
- 10. EXPULSION:** Students may be removed from training, without refund, at any time for violating Academy rules and regulations.
- 11.
